Significant slowdown in private sector investments in capacity building likely to impact demand negatively. Much higher dependence on public sector investments.

Mr R Ramesh Babu, Director of IVAMA Association and Managing Director of Velan Valves India Pvt Ltd explained that market analysis plays very vital role in conducting the business.
